**TENDER CALL NOTICE**

The Koraput Central Cooperative Bank Ltd., Jeypore intends to undertake the preparation of Detailed Project Reports (DPRs) for various developmental projects in the areas mentioned below. Proposals are invited from registered architectural consultants/consulting firms with relevant experience in preparing DPRs for building projects.

Interested registered architectural firms are requested to submit their sealed quotations to the undersigned on or before 02.08.2025 (5:00 P.M) along with a security deposit of ₹20,000 (Rupees Twenty Thousand only) in favour of the Secretary, Koraput Central Cooperative Bank Ltd., Jeypore. The submitted quotations will be opened on Dtd.04.08.2025 at 4:00 P.M in the presence of the members or their authorized representatives.

**Eligibility Criteria:**

1. The firm/architectural consultant must be registered with the Council of Architecture and should provide a valid registration number.
2. The organization should have an average annual turnover of ₹50 lakhs from consultancy services in the last three years.
3. Preference will be given to firms/architects who have successfully completed projects valued at more than ₹50 lakhs. Supporting documents, including qualification details of personnel, must be enclosed.
4. The bidder must not be disqualified from undertaking any government work in Odisha or any banking projects.
5. Interested firms/architects may visit the proposed project sites of KCC Bank Ltd., Jeypore, on or before 31.07.2025 (during office hours, except public holidays). No TA, DA, or HA will be provided by the bank.

1. The interested architectural firms/consultants must quote their price as a percentage of the total project cost for preparation of DPR and periodic supervision of work.
2. The interested architectural firms/consultants must quote their price as lumpsum for conducting soil test upto a depth of 10m and preparing report from a government approved lab.
3. The quoted percentage shall cover all consultancy charges, including DPR preparation, architectural design, structural design, estimation, and Preparation of BOQ.
4. The quotation must be submitted in a sealed envelope, clearly mentioning the percentage rate quoted for the project and Lumpsum price for soil testing of each bore.
5. Incomplete quotations or those received after the deadline shall be rejected.
6. The shortlisting of firms will be based on the competitive percentage rate offered.
